


ELTI - EU CAP Organization Champion



ELTI level of representativeness


EU leaf tobacco contracted volumes (Tons) Crop 2020

ELTI main figures

- 11 tobacco producing countries
- 76,000 hectares of tobacco cultivated land
- **▶ 150,000** tobacco tons delivered
- **500**M€ tobacco farmers revenue (commercial price paid)
- ◆ 12 National growers' Associations
- 46 Producers Organisations/Cooperatives
- **▶ 51,000** individual growers/farms
- 4 first processors' National Associations
- 18 first processing Companies
- ◆ 350,000 workers (50% women) + tens of thousands in associated jobs

ELTI goals

- Strengthen the aggregation and the contractual power of EU tobacco growers to achieve farming economic sustainability
- Officially represent the EU leaf tobacco sector common issues at EU Institutions to re-gain dignity for the tobacco growers among all EU farmers, fighting discrimination in the CAP
- Define EU umbrella harmonized rules for the proper functioning and control of the leaf tobacco market, tackling the illicit
- Achieve the world best quality standards in terms of leaf tobacco integrity, overall quality, Good Agriculture and Labour Practices
- Provide economic sustainability and perspectives to EU leaf tobacco, boosting manufacturers' multiannual purchase programs and commitments
- Support the activities of national IBOs or growers' and processors' Associations in MS without national IBOs, in a coordinated way and increase position and level of representativeness


ELTI activities in progress

Amendments to the CAP:

- Remove the current hypocrite discrimination of tobacco growers (exclusion from coupled subsidies and sectoral strategic plans)
- Recognize the role of recognized EU transnational Interbranch Organizations, allowing to extend to all operators the agreed rules and provide financing for their functioning
- Negotiates with international manufacturers (Philip Morris, Japan Tobacco, British American Tobacco and Imperial Brands) to obtain mid-term commitments to continue to buy adequate volumes of raw tobacco from <u>all</u> the EU producing countries
- Implementation of an EU umbrella regulation to control the marketing of raw tobacco to:
 - Certify the legality of the EU grown/processed tobacco tackle illicit trade
 - Definitively exclude EU raw tobacco from the risk of applying excise duties

Control system requirements

- 1. All operators to be authorized/registered
- 2. Cultivation contracts compulsory (CAP CMO rules)
- 3. Commercial contracts/shipments registered/traced
- 4. EU centralized database (OLAF, Agri, Taxud)
- 5. Controls (Administrative, on site, satellite, etc.)
- 6. Sanctions on non-compliant (seizure, destruction)

- ✓ Establish a permanent EU level tobacco table: ELTI, MoAs, PermReps, MEP, EFFAT, experts
- ✓ Define EU level raw tobacco:
 - ✓ Phytosanitary strategy
 - ✓ Good Agricultural Practices
 - ✓ ESG and Corporate Due Diligence common rules
- ✓ Apply the ELTI Labour Code of conduct (with EFFAT)
- ✓ Establish ELTI specialized Working Groups
